## introduction

This deed relates to the AVX Limited Pension Scheme (the Scheme).

The present trustees of the Scheme are the Continuing Trustees.

The Principal Employer has power to appoint and remove trustees of the Scheme under clause 16 of a definitive trust deed dated 20 September 1991 (the *Deed*).

The Principal Employer wishes to appoint the New Trustees to be trustees of the Scheme.

The Retiring Trustee was a member-nominated trustee for the purposes of section 241 of the Pensions Act 2004 and completed his five year term of office as a member-nominated trustee on 31 October 2011. The parties to this deed wish to confirm the retirement of the Retiring Trustee from the office of trustee of the Scheme with effect on and from 1 November 2011.

The New Trustees are member-nominated trustees for the purposes of section 241 of the Pensions Act 2004

## Effect of this deed

- Using its power under clause 16 of the Deed and all other enabling powers, the Principal Employer appoints the New Trustees to be trustees of the Scheme and to act jointly with the Continuing Trustees for all the purposes of the Scheme for a term of five years from 1 November 2011.
- 2 The New Trustees agree to act accordingly.
- The Principal Employer, the Continuing Trustees and the New Trustees confirm the retirement and discharge of the Retiring Trustee from the office of trustee of the Scheme,
- The Continuing Trustees and the New Trustees declare that they will hold all monies, deposits, securities, investments, property and income for the time being representing the assets of the Scheme upon the trusts of the Scheme and subject to the powers, conditions and provisions which apply to the Scheme.

- Each New Trustee and each of the Continuing Trustees confirms that he or she is not disqualified, prohibited or suspended from being, or ineligible to be, a trustee of the Scheme under the Pensions Act 1995.
- This deed may be executed in any number of counterparts and by the parties to it on separate counterparts, each of which will be an original, but all of which tegether will constitute one and the same instrument.
