



- (C) The Trustees are the present trustees of the Scheme.
- (D) Under the terms of the Trust Deed, the Principal Employer may, with the consent of the Trustees, alter the Trust Deed or the Rules, subject to the restrictions about making alterations described in the Trust Deed.
- (E) The Principal Employer wants to alter the provisions of the Rules with effect from 1 May 2004.

EFFECT OF THIS DEED:

- The Trustees confirm they are satisfied that neither the certification requirements nor the requirements for consent referred to in section 67(3)(a) of the Pensions Act 1995 apply in respect of any member or other person affected by any of the alterations made by this deed
- The Principal Employer, with the consent of the Trustees, alters the provisions of the Scheme.
- The alterations made by this deed take effect as from and including 1 May 2004.
- Each Trustee confirms that he/she is not disqualified, suspended or prohibited from being, or ineligible to be, a trustee of the Scheme under the Pensions Act 1995.
- Each of the parties to this document intends it to be a deed and agrees to execute and deliver it as a deed.



- 6 With effect from 1 May 2004
 - (a) Section 2. of SCHEDULE PART III is replaced by the following:
 - "2. <u>Member's Contributions applicable to Rule 3(a)(i)</u>

A rate of 8% of a Member's Pensionable Pay."

- (b) Section 2 of SCHEDULE PART III (APPLICABLE ONLY TO VARELCO MEMBERS) is replaced by the following:
 - "2. VARELCO MEMBER'S CONTRIBUTIONS APPLICABLE TO RULE 3(a)(i) OF THE PLAN

A rate throughout a Plan Year of 8% of a Varelco Member's Contribution Salary determined on the Entry Date at the start of that Plan Year."
