NI038344) whose registered office is at Linen Loft, Adelaide Street, Belfast, Northern Ireland, BT2 8FE (the "**Continuing Trustees**");
- (3) **MICHAEL EDWARD HUFNAGEL** c/o 1 AVX Boulevard, Fountain Inn, South Carolina, 29644, USA (the "**Retiring Trustee**"); and
- (4) **CHAD DOUGLAS BASKIN** c/o 1 AVX Boulevard, Fountain Inn, South Carolina, 29644, USA (the "**New Trustee**").

Background

- 1 This deed is supplemental to the definitive deed (the "**Trust Deed**") and rules dated 20 September 1991 (as amended) made between the Principal Employer (1) and the then trustees (2) by which the AVX Limited Pension Scheme (the "**Scheme**") is currently governed.
- 2 The Principal Employer is the current principal employer of the Scheme.
- 3 The Continuing Trustees are its current trustees.
- 4 By Clause 16 (a) and Clause T1 of the Trust Deed (Clause T1 applies to the Scheme by virtue of amendments made by the amending deed dated 8 November 2002), the power to remove and appoint additional trustees of the Scheme is vested in the Principal Employer of the Scheme. The effective date of any such removal or appointment may be retrospective or prospective.
- 5 The Principal Employer wishes to confirm the removal of the Retiring Trustee as trustee of the Scheme with effect on and from 30 June 2021 (the "**Effective Date**").
- 6 The Retiring Trustee has consented to their removal as trustee of the Scheme.
- 7 The Principal Employer wishes to confirm the appointment of the New Trustee as trustee of the Scheme with effect on and from the Effective Date.
- 8 The New Trustee has consented to act as trustee of the Scheme.

Operative provisions

- 1 This deed takes effect on the Effective Date.
- 2 The Principal Employer in exercise of its power under Clause 16 (a) and Clause T1 of the Trust Deed and other enabling powers (statutory or otherwise), removes the Retiring Trustee as trustee of the Scheme and appoints the New Trustee as trustee of the Scheme to act jointly with the Continuing Trustees.
- 3 The Retiring Trustee has consented to their removal as trustee of the Scheme.

- 4 The New Trustee has consented to act as trustee of the Scheme.
- 5 The Continuing Trustees acknowledge the removal of the Retiring Trustee and the appointment of the New Trustee.
- 6 If any of the property subject to the trusts of the Scheme does not vest in the Continuing Trustees and the New Trustee by virtue of the Trustee Act 1925, the Continuing Trustees, the Retiring Trustee, and the New Trustee agree to take the steps required to transfer it into the names of the Continuing Trustees and the New Trustee.
- 7 This deed may be signed in any number of counterparts and this has the same effect as if the signatures on counterparts were on a single copy of this deed. Each counterpart, when executed and delivered, shall constitute an original of this deed, but all the executed and delivered counterparts shall together constitute a single instrument.






