- The Principal Employer with the consent of the Trustees wish to amend the Rules as 4 set out in this deed.
- 5 The Trustees are satisfied that the modifications made by this deed are not regulated modifications within the meaning of section 67 of the Pensions Act 1995.
- 6 The Scheme was a salary related contracted-out scheme until 6 April 2016 when contracting out was abolished by legislation. That legislation prohibits all but specified alterations being made to scheme rules about members' contracted-out rights. The Trustees are satisfied that this deed does not make any prohibited alteration.

Operative provisions

- 1 In exercise of the power referred to in the Background, the Principal Employer amends and/ or modifies the Definitive Deed and the Rules with effect from the date of this deed in the way set out in the schedule to this deed.
- 2 The Trustees consent to the amendments made by this deed.
- 3 This deed may be signed in any number of counterparts and this has the same effect as if the signatures on counterparts were on a single copy of this deed. Each counterpart, when executed and delivered, shall constitute an original of this deed, but all the executed and delivered counterparts shall together constitute a single instrument.
